Pilot Background

Under the new NIH Policy for Data Management and Sharing, each NIH Institute, Center, and Office (ICO) has the flexibility to develop more specific requirements to best meet the needs of the particular field(s) it funds; however, significant variation in ICO-specific requirements will place substantial administrative burden on researchers to first navigate the varying requirements before they can begin developing their DMS Plan.

The FDP NIH DMS Pilot is an FDP and NIH collaboration engaging NIH ICOs, Office of Extramural Research SMEs, the Office of Science Policy and OPERA/Compliance which aims to:

- Generate greater consistency in DMS Plan requirements across NIH ICs and programs and
- Mitigate the administrative burden for researchers associated with DMS Plan development and implementation.



Pilot Phase 1: NIH DMS Plan Template Pilot

- We will test the effectiveness and usability of two DMS Plan templates developed in collaboration with representatives from participating ICs:
 - **Alpha Template** is a prescriptive template designed to limit the need for free text entry
 - **Bravo Template** aims to provide detailed prompts as well as more options to include free text responses as necessary.
- We will gather data from the researcher/faculty perspective as well as the NIH program perspective.

Common Themes

- So far, most applicants are using the OER DMS Plan format page.
- Vague reasons for not sharing data.
- Planning to share only through “publication” and “conferences”, or “by request.”
- Not using an established repository or not committing to one.
- Naming a data repository that is not a good fit (not broadly accessible, inappropriate for the data type).
- When listing multiple repositories, not indicating which data goes to which.
- Lacking budget requests, lacking details when there is a budget request.
- Plans that used any template or included tables or lists were more likely to meet policy requirements .
- All data proposed in the Research Plan of the grant application should be discussed in the DMS plan.

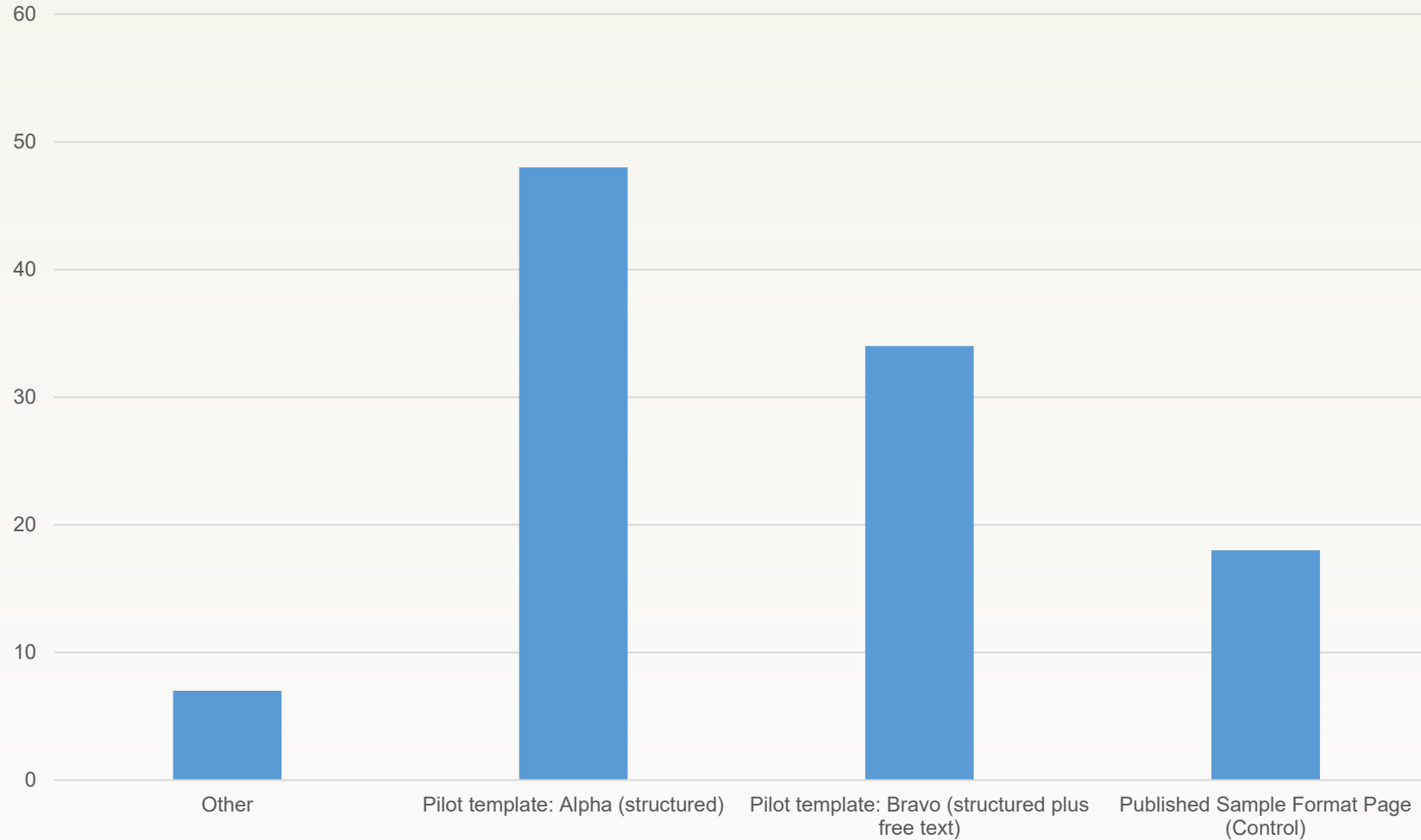

Early Researcher DMS Plan Submission Feedback

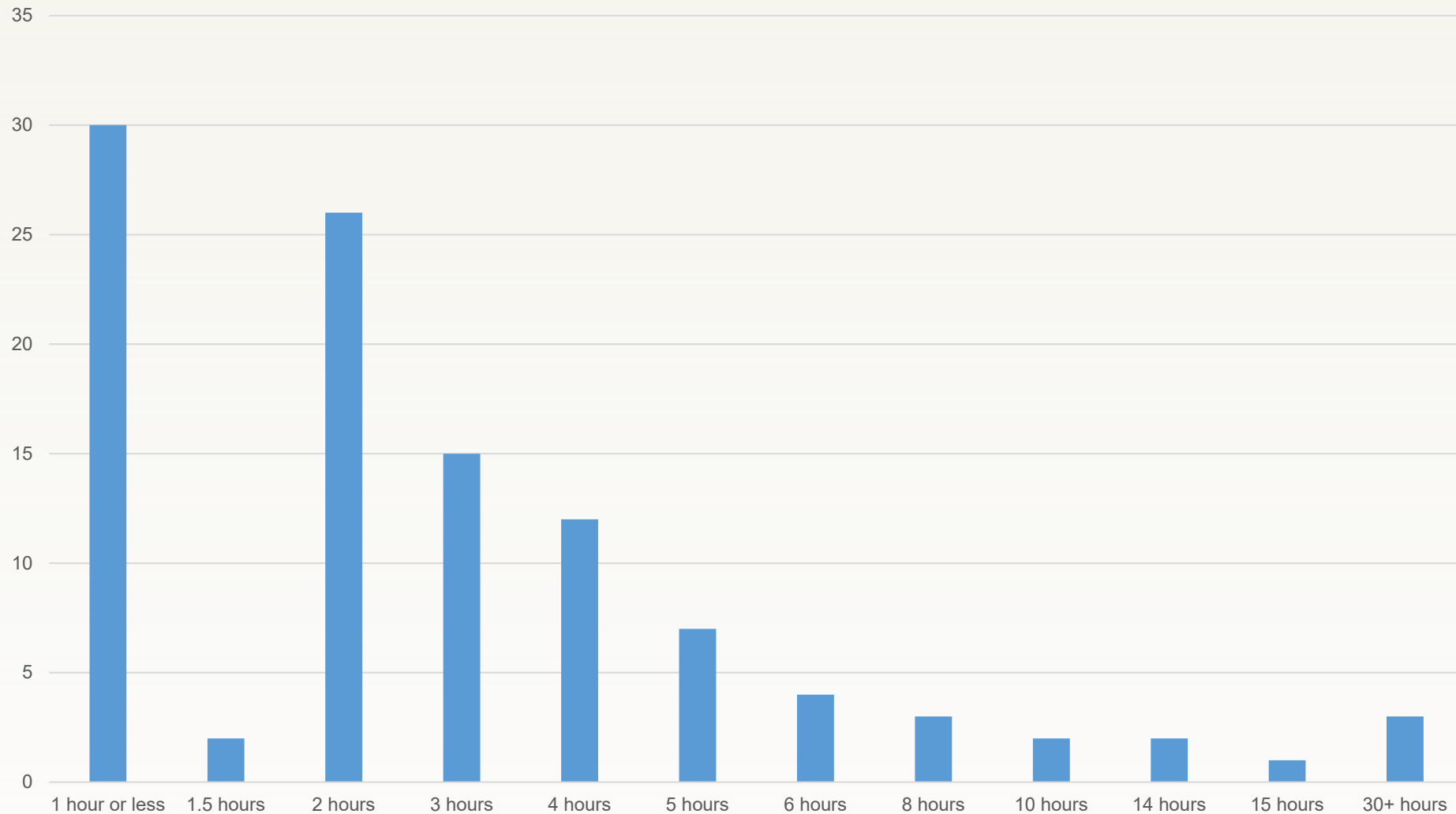


Which template did you submit?



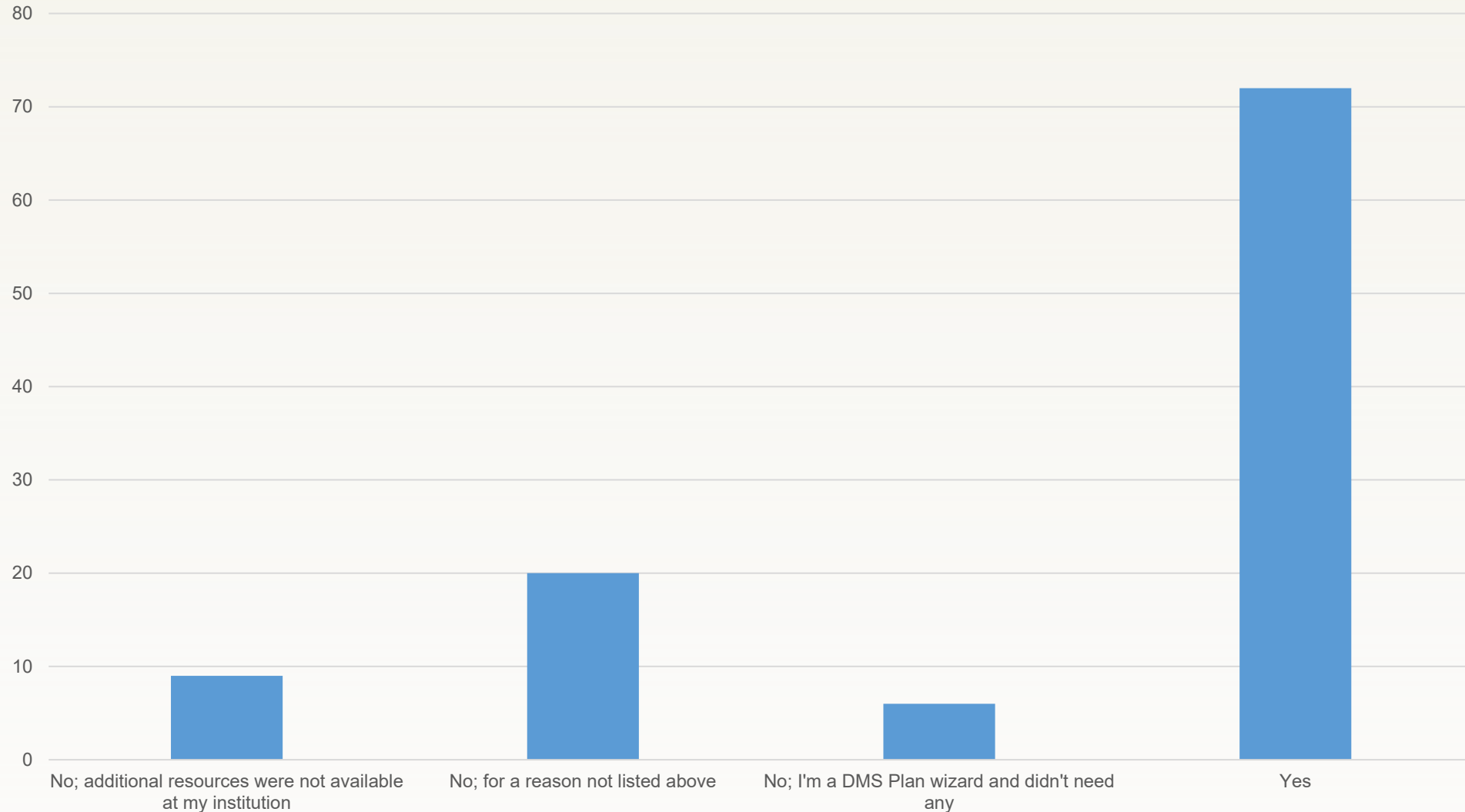


How much time did you spend completing the DMS Plan?



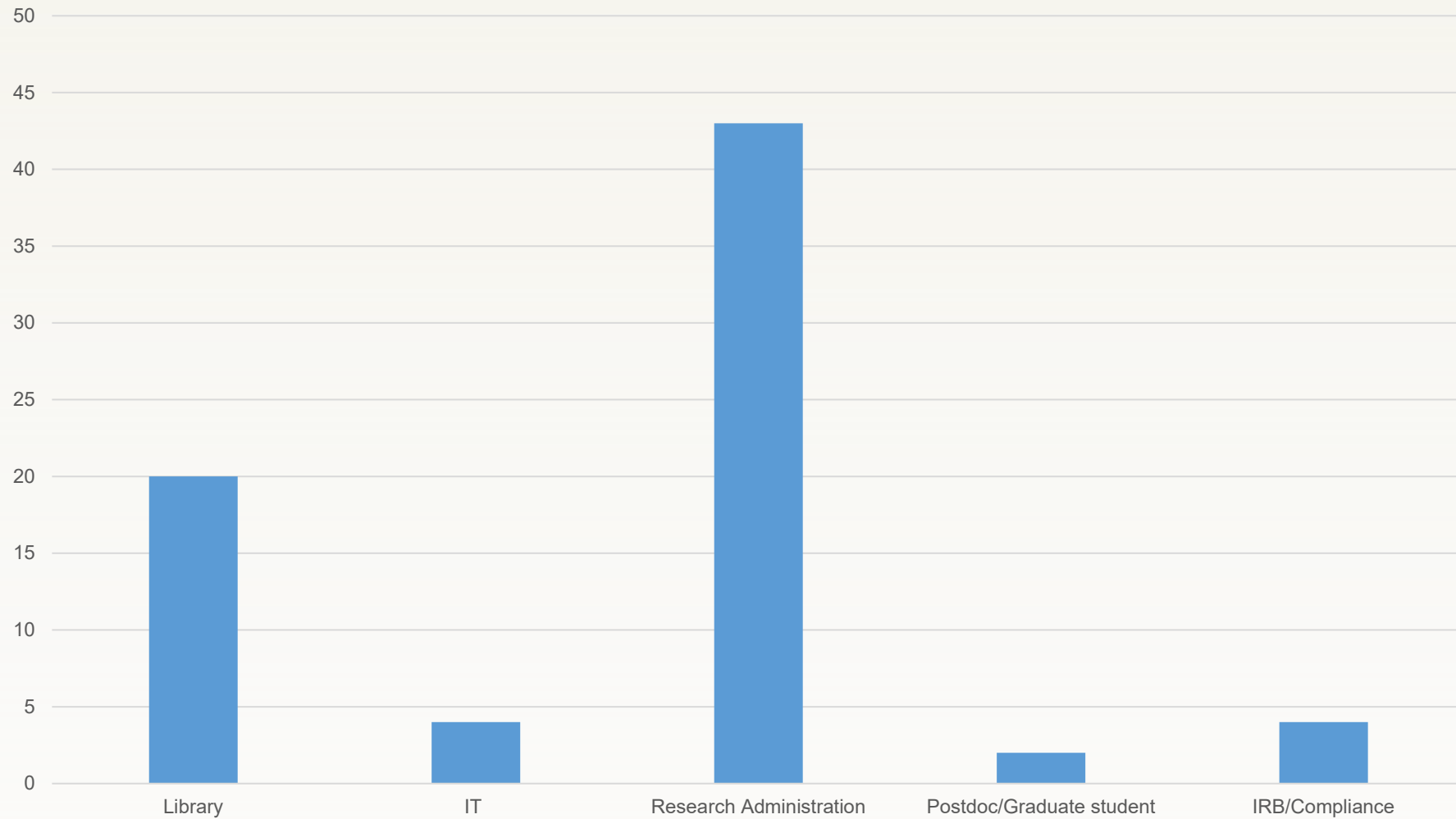


Did you have assistance from others to complete the DMS Plan?



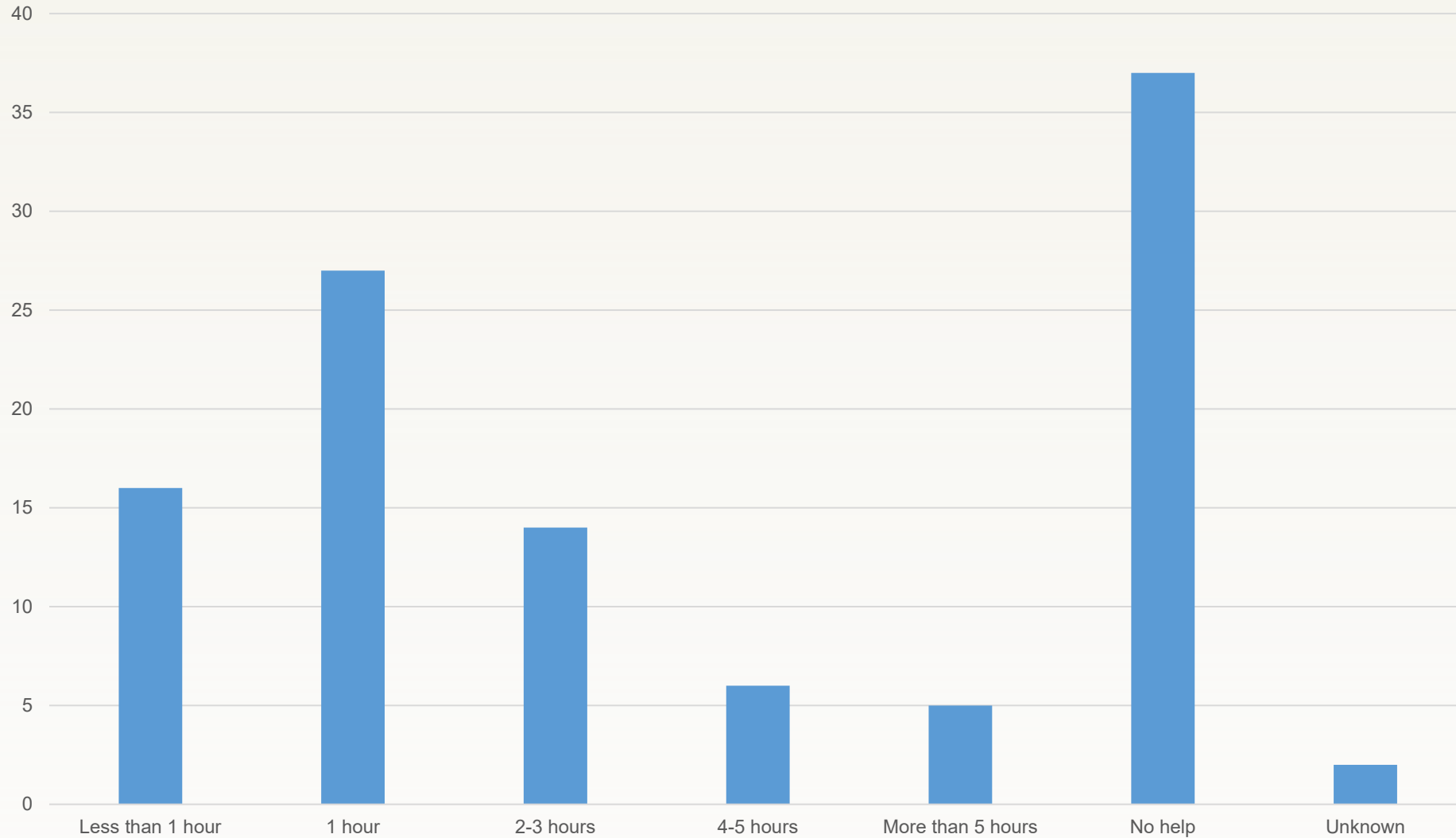


Who assisted you with creating your plan?



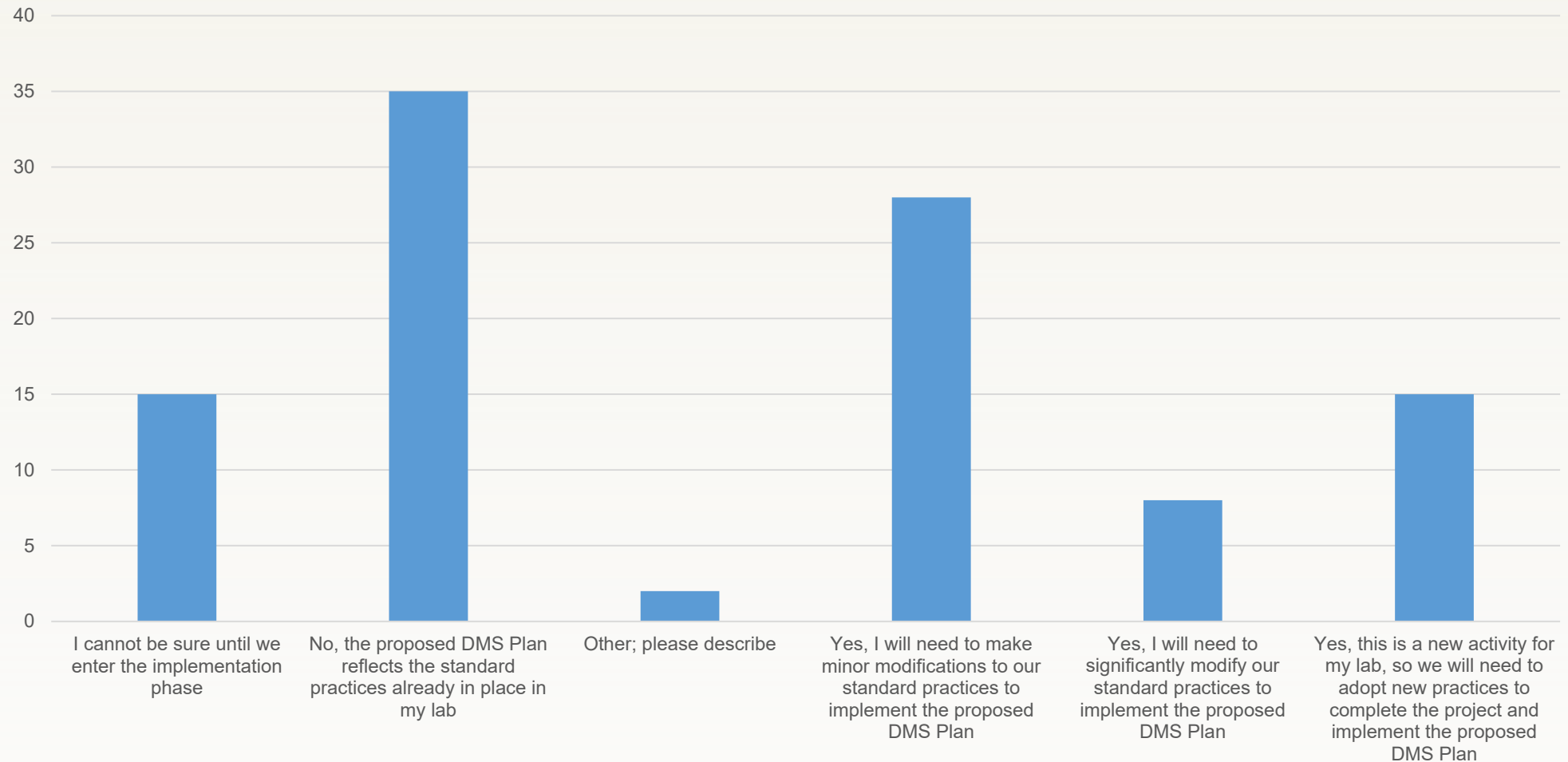


How much time did others spend assisting you to complete the DMS Plan?

DMPTool by the numbers

- 238 uses of Alpha in DMPTool.org (and 123 test plans)
- 51 uses of Bravo in DMPTool.org (and 27 test plans)

Initial Qualitative Feedback

- In order of prevalence:
 - Technical issues trying to use the template
 - Generally need more guidance on the level of detail required, instructions on how to complete the plan, and information on what meets data management and sharing best practices
 - Specifically, more guidance needed when using secondary data
 - The pilot templates seem more targeted towards human subjects research
 - It is very difficult to know some of the requested information at the proposal stage
 - The plan seems long and requests potentially redundant information

Planning for Oversight of DMS Plans

- Plans should, “Indicate how compliance with the Plan will be monitored and managed, frequency of oversight, and by whom (e.g., titles, roles)”
- How are institutions planning to approach monitoring and oversight?
- What guidance has your institution provided on completing this section of the DMS Plan?



Pilot Phase 2: Cost Policies

- Establish common cost principles, identify types of costs required, and determine how to identify additional/unforeseen costs that may be required to meet the spirit of the data sharing policy.



IC Observations – Budget Themes

- Plans are lacking budget requests, and lacking details when there is a budget request.
- Cost requests need to account for specific costs such as:
 - Personnel support for preparing data submissions to repositories
 - Collaborations with institutional librarians or investigators on other NIH awards, such as data coordinating centers
 - Repository fees



Pilot Phase 2: Cost Policies

- Priority Remains Focused on Phase 1
- Pre-Planning Thoughts – Phase 2
 - Improving Budgeting of DMS Costs
 - Create tools (Personnel Cost Estimator)
 - Guidance on allowability (direct, indirect, and service center costs)
 - Addressing Post-closing related costs
 - Modular budgets
 - Understanding the Total Cost to the institution
 - If not a direct charge, where are the institutional costs being incurred (and possibly recovered)



Initial Phase 2 Project: Personnel Effort Estimator

- Personnel effort represents a significant DMS cost
- Despite application budgeting instruction update, still important to accurately estimate effort required:
 - NIH still requires information on costs within the budget justification
 - Need to ensure that sufficient personnel effort is allotted to complete the necessary DMS activities
